WARRANTY APPLICATION

- Complete application
- Project must meet specifications



ADDITIONAL DOCUMENTATION

- Receipt/proof of purchase
- Product Lot # (no lot #'s = no warranty)
- Before and after photos (optional for marketing/review purposes only)



APPROVAL

Confirmation email with warranty tracking number



LABOR AND MATERIAL WARRANTIES

REFER TO PRICING CHART



PRE-APPROVAL (MINIMUM 14 DAYS BEFORE STARTING)

- Must strictly adhere to appropriate specification
- Complete application, submit project photos and description
- Adhesion testing, moisture scanning, and core sampling required
- Additional testing/photos may be required



DURING PROJECT (IF APPROVED)

- Photos (prep, detail, field, finish)
- Punch-list completion
- Additional photos/documentation may be required



APPROVAL

- Completed Warranty Certificate signed by contractor and owner
- Warranty payment processed
- Warranty certificate countersigned by Castagra, warranty tracking number issued
- Contractor labor liability 3-5 years
